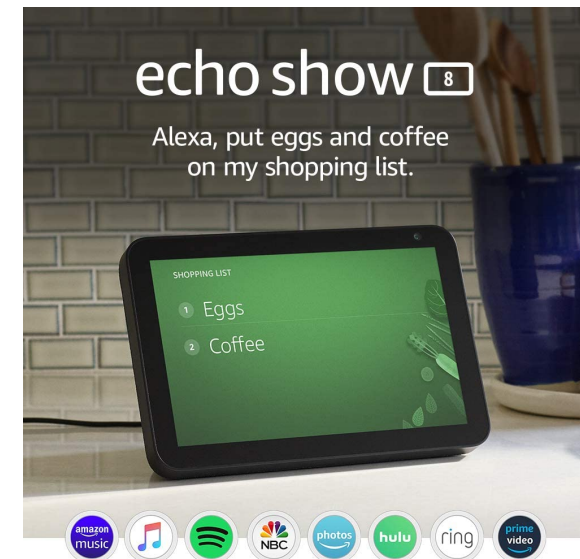

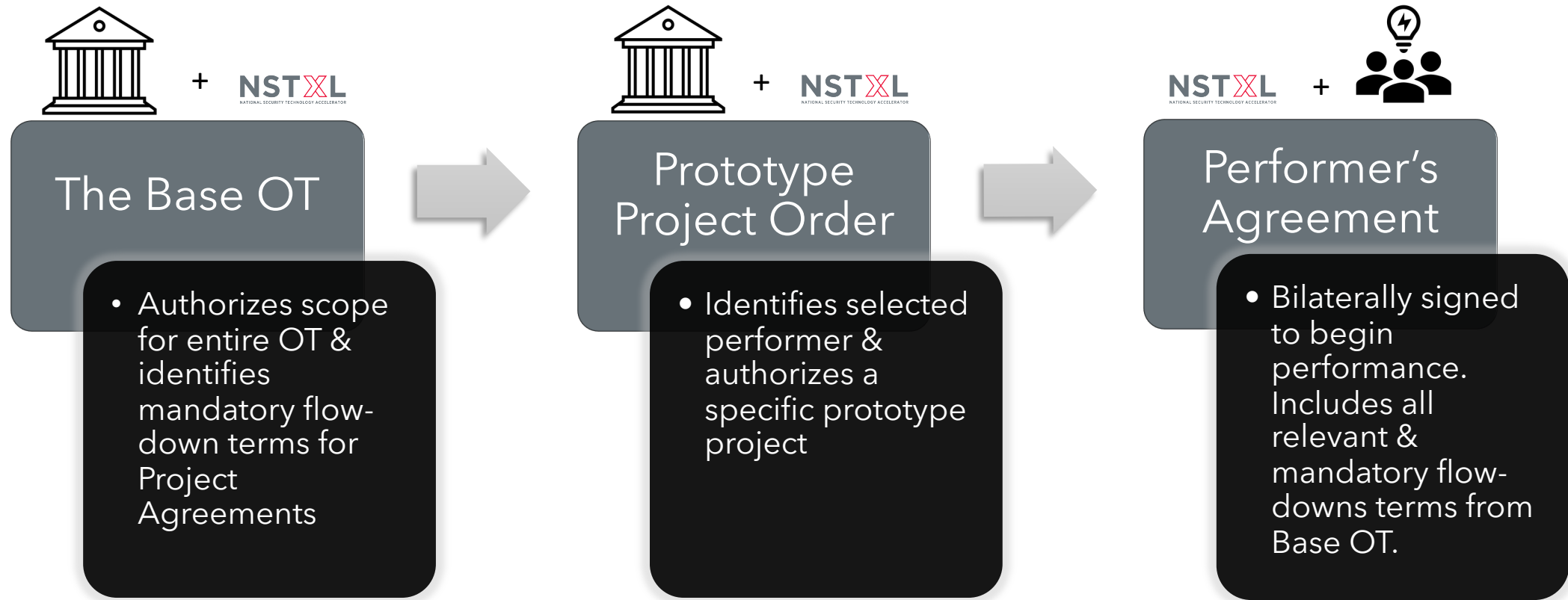

- Any unique Government preferences



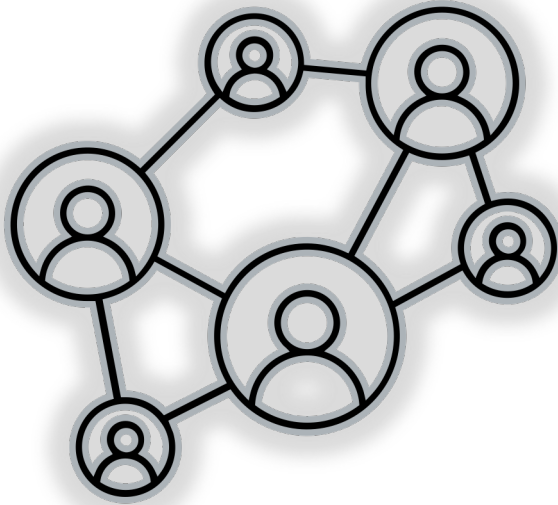

Project Launch



- NSTXL will typically lead an introductory Post-Award Conference to kick-off the project, introduce key players, and discuss communication flow
- Conducted virtually
- The introductory session is not a replacement for the initial technical engagement or first payable milestone
- Performers are strongly encouraged to provide ~5 slides summarizing their solution

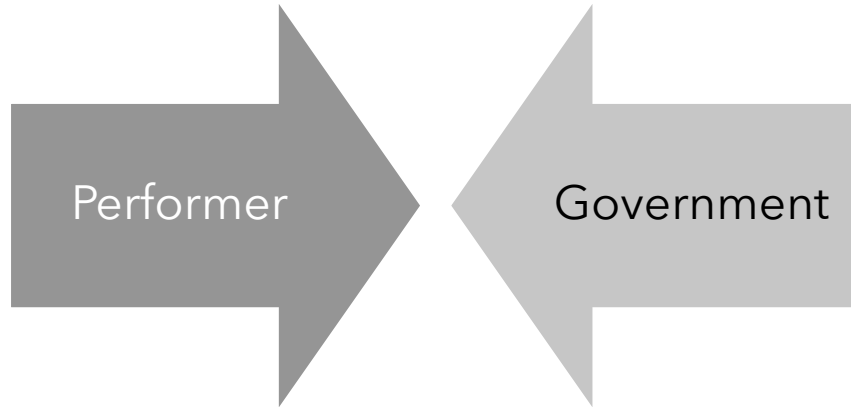

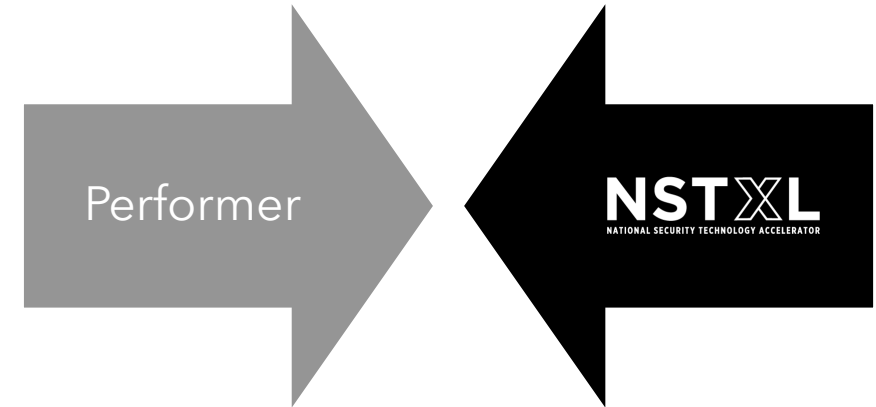

Communication Channels



- Technical exchanges



- Request for Milestone Revision(s)
- Payment/Invoicing Questions
- Request for Administrative Updates
- Performer's Agreement

Remember: Modifications to the project will likely change the **Project Order** (Government & NSTXL) and **Performer's Agreement** (NSTXL & Performer).

The Government must approve almost all changes.

Example 1

“Our deliverable is going to be about 45 days late.” - Performer

- Is the customer aware?
- Cause of delay?
- Any anticipated pricing impacts?
- Impacts to subsequent milestones?
- NSTXL will coordinate concurrence from Government Technical lead & seek approval from Agreements Officer
- Will likely result in modification to Project Order & Performer’s Agreement

Example 2

“We require 2 more prototypes to properly assess utility .” - The USG

- NSTXL sends request to Performer on behalf of the **Agreements Officer**
- Once an agreement is reached regarding the modification, NSTXL will request Performer concurrence regarding any updates to the Project Order
- NSTXL will update the Performer’s Agreement (pursuant to the revised Order) and provide to the Performer for signature.

Getting Paid

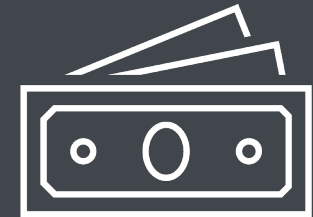
1. Successfully complete a payable milestone
2. Submit a populated Certificate of Completion to your AOR/Technical Lead
3. Receive signed CoC from Government & forward to NSTXL with a company invoice
4. NSTXL processes submission in iRAPT/WAWF
5. Upon receipt of funding, NSTXL will pay the invoice via Bill.com

Takeaways

NSTXL is responsible for payments to Performers

Email the CoC & Invoice to **success@nstxl.org**

Common Obstacles

- Inconsistent understanding of project's purpose
 - This may occur between the Performer and the Government, however, there may also be disagreement amongst other stakeholders - pay attention to the decision makers
- Delayed communication
- Not involving NSTXL and/or the Agreements Officer
- Incomplete payment requests (e.g., missing invoice)
- Discrepancies between amount billed and the project's payable milestone schedule

Takeaways

- Even if not required by the Agreement, a brief monthly report is recommended
- Put requests or updates in writing
- Overcommunicate if needed
- NSTXL can help mitigate potential issues before they become showstoppers

“...It’s not you, it’s me.” 

- The Government can elect to discontinue the project at any time
- Be cognizant of upcoming decision points & potential “off-ramps”
- Ensure you understand the rationale behind the decision
 - Funding Cut? Poor Performance? Change in mission?
- Confirm final disposition of IP, Data Rights, and GFP
- If written direction to cease work is delivered – follow the instructions!

Reaching Success

- Stay focused on the end-user...they are depending on you
- Communicate early, often, and clearly
- Ask questions and regularly confirm customer's vision
- Maintain alignment to milestone schedule & contractual commitments
